Vide CSIR-IICT Notice dated 03.02.2026, the provisional list of selected candidates was notified which was subsequently withdrawn vide Notice dated 19.02.2026 due to mismatch in the answer key of Paper-II. Further Question Papers and Answer Keys of Paper- I, II and III of Competitive Written Examination held on 21.12.2025 were uploaded on the Website and representations were invited from candidates against those answer keys. The representations received were reviewed by the experts and the Final Answer Keys were notified vide Notice dated 24.02.2026.

After disposal of representations received from the candidates and on completion of re-evaluation process, following candidates have been declared as provisionally selected for the post of Technician(1) for the post codes- ELEC 01, MFIT 02, IMEC 03, LACP 04, MRAC 05, MEMV 06 and DMNC 07, advertised vide Advt. No. 02/2024.

As notified vide notice dated 19.02.2026, the Provisional Selection List stands withdrawn. The inconvenience caused in this regard is regretted.

Marks obtained by all the candidates who attended the Competitive Written Examination is attached as Annexure-I

As notified in the advertisement the Competitive Written Examination consists of three papers. Paper II & III were to be evaluated only for those candidates who secure the minimum threshold marks (as determined by the Selection Committee) in Paper-I. The final merit list was prepared only on the basis of the marks obtained by the candidates in Paper- II and Paper- III.

Accordingly, the category-wise minimum threshold marks (%) for qualifying Paper-I determined by the Selection Committee are as follows.
