- 1. E-Bids are invited through the electronic tendering process and the Tender Document can be downloaded from the e-Tender portal of Central Public Procurement (CPP) Portal of the Government of India i.e. <a href="https://etenders.gov.in">https://etenders.gov.in</a>. A copy of the Tender Document is also available on CSIR-IICT Website, <a href="http://www.iictindia.org">http://www.iictindia.org</a> for information. However, the submission of e-Bids will be only through the CPP e-Tender portal <a href="https://etenders.gov.in">https://etenders.gov.in</a>. Bids will not be accepted in any other form.
- 2. For participation in e-procurement all bidders (including foreign bidders) need to enrol themselves on the Central Public Procurement Portal (URL: <a href="https://etenders.gov.in">https://etenders.gov.in</a>) which will be free of cost. For further information, kindly refer "Bidder Manual Kit" in the said portal.
- 3. Only enrolled/registered bidders with the above said portal shall be allowed to participate in the e-tendering process
- 4. The quotation must be in the form furnished by the Purchaser and should be free from corrections/erasures. In case there is any unavoidable correction, it should be properly attested. If not, the quotation will not be considered. Hand written Quotations will not be considered.
